

THIRD PARTY TRADING AUTHORIZATION

To: Riches Depot Securities Co., Limited (hereinafter referred to "Riches Depot")

Rm 1301 Prosperity Tower, 39 Queen's Road Central, Central, HK

The undersigned client(s) (the "Client") hereby authorizes the undersigned authorized person (the "Authorized Person") as the Client's agent and attorney to buy, sell, sell short, borrow, lend, tender, exchange, convert, write, exercise and generally deal in and with stocks, bonds, option contracts and any other securities (hereinafter referred to as "Securities") on margin or otherwise under and in accordance with Riches Depot's terms and conditions for the Client's account (the "Account") and risk and in the Client's name or number on Riches Depot's books.

Riches Depot may follow the instructions of the Authorized Person in every respect concerning the Account, and make deliveries or otherwise transfers Securities and/or other investment and/or paying monies to the Authorized Person or otherwise as the Authorized Person may order or direct, and whether or not any such delivery or other transfer is to be made against payment, or such payment is to be made against delivery or other transfer.

In all matters and things aforementioned, as well as in all other things necessary or incidental to the furtherance or conduct of the Account of the Client, the Authorized Person is authorized to act for the Client and in the Client's behalf in the same manner and with the same force and effect as the Client might or could do.

The Client acknowledges that any transaction entered into by the Authorized Person pursuant to the above authorities will be subject to and governed by the account opening documents. The Client further understands and agrees that neither Riches Depot, nor any of Riches Depot's directors, officers, employees, agents or affiliates, are or will be in any way responsible for any loss to the Client occasioned by the actions of the Authorized Person hereunder and, without prejudice to the generality of the foregoing, the Client hereby agrees to fully indemnify and hold Riches Depot harmless from, and to pay Riches Depot promptly on demand, any and all damages, losses, liabilities, cost (including legal costs on a full indemnity basis) and expenses whatsoever (including consequential and special damage) arising directly or indirectly therefrom or debit balance due thereon.

The Client hereby agrees that Riches Depot's acceptance of this authorization and indemnity or any part thereof is subject to Riches Depot's approval at Riches Depot's sole discretion and Riches Depot is not in any way bound to act on the instructions of the Authorized Person whether in respect of trading of securities or withdrawal of securities and/or funds or otherwise contemplated by this authorization and indemnity.

This authorization and indemnity is in addition to (and in no way limits or restricts) any rights which Riches Depot may have under the account opening documents or any other agreement or agreements between the Client and Riches Depot.

This authorization and indemnity is also a continuing one and shall remain in full force and effect until terminated by the Client by, and with effect from actual receipt by Riches Depot of, written notice, but such termination shall not affect any liability in any way resulting from transactions initiated prior to such revocation.

This authorization and indemnity and its enforcement shall be governed by the laws of the Hong Kong Special Administrative Region, and its provisions shall be continuous and shall inure to the benefit of Riches Depot irrespective of any change or changes at any time in the personnel thereof for any cause whatsoever, and of any assigns or successors of Riches Depot.

If any provision of this authorization and indemnity shall be rendered invalid for any reason, such provision shall be deemed modified or superseded, as the case may be, and all other provisions and the provision so modified shall in all respects continue and be in full force and effect.
